EPS, based in Hyde Park, Massachusetts, is a privately-held company founded in 2006 by entrepreneurs Brian Kerins and Patrick Manning. EPS provides mobile generator rentals primarily to utility companies as well as to commercial and industrial customers across New England. Sunbelt, a subsidiary of Ashtead Group plc (LSE: AHT), is one of the largest equipment rental companies in the U.S., with a fleet of approximately \$3 billion. Ashtead Group is an international equipment rental company based in the UK with a \$7.6 billion market cap.

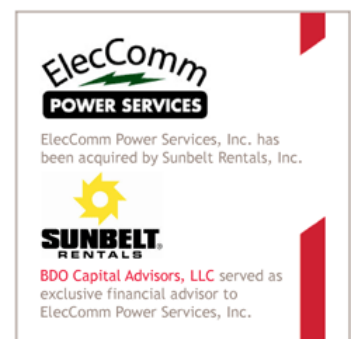
